

About 196 children benefited from IFFAMPAC's educational material distribution and it is our sincere hope that the program will continue to grow so that more families in Africa may benefit. Through IFFAMPAC's Educational Support Program families can begin to transition from illiteracy and begin to see a prosperous future because they are literate. Literacy exposes children and youths to future educational prospects, knowledge and will help them to more effectively lobby for social rights in the future.

IFFAMPAC's Africa Representative, Mr. Lombe, presented the educational materials to the children and youths while emphasizing that education is the key to social development in Africa. Mr. Lombe further emphasized strong collaboration and networking among organizations in Africa if poverty and high levels of illiteracy are to be reduced.



Most children lack educational materials that enable them read and write because of this, under its Educational Support Program, IFFAMPAC is committed to continued donation of educational materials to families in need. Since the inception of its Educational Support Program, IFFAMPAC has donated educational materials to Vision of Hope in Kanyama in 2008 and to Maheba Refugee Camp in 2009. The program is ongoing and will continue to be expanded and replicated in other African countries with a view toward enhancing our contribution to the United Nations Millennium Development Goals (MDG).

IFFAMPAC firmly believes that education is a great tool with which to fight poverty and to attain peaceful coexistence among various societal inhabitants. Proper education helps children and families better express themselves which contributes to social justice, community harmony and societal development. IFFAMPAC is committed to helping the families of missing persons to achieve each of those laudable goals and we are very thankful to Amano Sanitary Services Enterprise for supporting our efforts.

In the year 2011 IFFAMPAC is committed to intensifying the education support to African families, because education investment is an assurance for sustainable society. Further, IFFAMPAC realizes that the United Nations MDGs on

# IFFAMPAC PARTICIPATES AT REAF WORKSHOP

Lusaka-Zambia- IFFAMPAC was invited by Rural Equity for Africa (REAF) to be a featured speaker and to participate in the special workshop focusing on the plight of women refugees in Africa. The workshop was held at the YWCA in Zambia. Amongst the invited guests and speakers were: Mr. Evans Lombe, IFFAMPAC Africa Representative; Mrs. Siwale, Executive Director of YWCA-Zambia; Reverend Mulumo from the United Church of Zambia; and Mr. Chela, Coordinator for African Human Action. The workshop was moderated by the REAF Executive Director, Ms. Laurah Harrison. Also amongst the participants were refugee women from the Great Lakes Women Refugees Family Association in Zambia (GLWRZ).

The workshop focused on issues of refugee women empowerment, gender based violence, legality of their status, networking and linking Great Lakes Women Refugees Family Association in Zambia to other organizations and individuals who can be of help to further their goal of empowering women.

The workshop emphasized the need to empower refugee women with entrepreneurship skills as a means for survival, and also to ensure that refugees are protected from further abuse.







IFFAMPAC's Africa Representative, Mr. Evans Lombe was privileged to speak at the workshop, emphasizing the need for more organizations to actively assist the projects of the Great Lakes Women Refugees Family Association in Zambia which focus on the welfare of women refugees who suffer from social stress, poverty, post traumatic stress and other economic problems imposed upon them as a result of armed conflicts. Mr. Lombe reaffirmed IFFAMPAC's commitment to network with organizations such as Rural Equity for Africa, YWCA, AHA and the Church in addressing the social and economic problems confronting women refugees in Africa.

IFFAMPAC reinforced its commitment to all participants that it will continue to collaborate and network with all organizations that recognize the importance of addressing issues of families of missing persons from armed conflicts in Africa and beyond. IFFAMPAC believes that forums such as workshops, seminars, conferences and summits are critical to show support of these families, and to communicate their messages to the international community.

# IFFAMPAC CONDUCTS FORMAL MEETINGS WITH THE AFRICAN UNION & AFRICAN GOVERNMENTS

On  $16^{th} - 21^{st}$  August, 2010 IFFAMPAC's President, Ms. Jane Durgom-Powers, and its Africa Representative, Mr. Evans Lombe, held a series of successful meetings in Addis Ababa, Ethiopia with representatives of the African Union. Separate meetings were also held with ambassadors and other government officials. The African governments of Ethiopia, Sierra Leone, Uganda, Kenya, Burundi, Liberia, Angola, and the State of Palestine met with IFFAMPAC independently to discuss its work with the families of missing persons from armed conflicts, and also to address economic, social, and legal issues confronting such families in their respective countries.

# <u>A BRIEF HISTORY OF IFFAMPAC</u>

Below is a brief list of the history and accomplishments of IFFAMPAC:

**1970s**: Our President first became involved with the issue of people who have disappeared and their families. She worked directly with families around the world, helping them to set up Family Associations. She began drafting national laws and reforms to assist surviving family members.

**February 2003:** The ICRC conference on The Missing recognized the need to unite and co-ordinate the work of the numerous associations of affected families in many parts of the world. Our President addressed the conference.

April 2003: IFFAMPAC was incorporated in the USA.

March 2006: IFFAMPAC was appointed to the United Nations Working Group on Persons who are unaccounted for in Connection with Events in Kosovo.

May 2006: The United Nations Economic and Social Council granted IFFAMPAC Special Consultative Status.

**December 2007:** IFFAMPAC was approved for association with the United Nations Department of Public Information (DPI).

March 2008: IFFAMPAC opened a Kosovo branch office in Pristine.

April 2008: IFFAMPAC opened an African branch office in Lusaka, Zambia.

September 2008: IFFAMPAC is chosen by the UN to conduct a workshop on families of missing persons from armed conflicts at the UN prestigious meeting in Paris, France celebrating the 60<sup>th</sup> anniversary of the Universal Declaration of Human Rights
